Mumbai International Airport Limited (the "**Organiser**" or "**MIAL**") is organising a shop and win contest at Chhatrapati Shivaji Maharaj International Airport, Mumbai for all the Passengers arriving at and/or departing from the Terminal 1 and Terminal 2 between 15/10/2023 (12:00 am (IST) till 10/01/2024 (11:59 pm (IST) (**both dates inclusive**) (the "**Contest Period**").

1. ACCEPTANCE

The Passenger, by participating in this Contest and by submitting the Coupon(s) for the Lucky Draw, do hereby irrevocably and unconditionally accept all the terms and conditions governing this Contest and waives and relinquishes all its rights to challenge any and/or all terms and conditions of this Contest.

2. DEFINITIONS

- 2.1 In addition to the terms defined elsewhere, in this general Terms & Conditions, the following words and expressions shall have the meanings set forth below, unless the context otherwise requires: -

 - F. "**Invoice**" shall mean the bill/receipt issued by the Outlet(s) to the passengers for the goods purchased by them at the Outlet and/or for the services availed by the passenger at CSMIA.

- H. **"Lucky Draw"** shall mean the procedure of randomly selecting the coupon;
- I. **"Organizer"** shall mean Mumbai International Airport Limited.
- J. **"Outlet(s)"** shall mean either (i) a food and beverages outlet(s) where food, snacks and beverages are served; or (iii) a retail outlet(s) where a retail shop is operated; or (iii) a duty free outlet where all the duty free goods are sold; or (iv) a service outlet(s) where any kind of passenger services are being rendered, as may be applicable, at Terminal 1 and Terminal 2 of CSMIA.
