Shop & Win by Thiruvananthapuram International Airport

ACCEPTANCE

The Contestant, by participating in this Campaign / Contest and by submitting the Coupon for the Shop N Win, do hereby irrevocably and unconditionally accept all the terms and conditions governing this Contest and waives and relinquishes all its rights to challenge any and/or all terms and conditions of this Contest.

DEFINITIONS

- In addition to the terms defined elsewhere, in this general Terms & Conditions, the following words and expressions shall have the meanings set forth below, unless the context otherwise requires: -
 - A. "Airport" or "TIA" shall mean the Thiruvananthapuram International Airport, Thiruvananthapuram.

THE CONTEST

- Submit the E-Coupons through mobile phone.
